All bid / tender documents are to be submitted online on the e-GP website. Tenders / bids shall be accepted only through online mode on the e-GP website and no manual submission of the same shall be entertained. Late tenders will not be accepted.

. The scanned copy of the Preliminary Agreement in Kerala stamp paper worth **Rs.220/-** duly filled and signed by the bidder shall also be submitted online. More details on EMD & cost of tender documents / bid submission fee are mentioned in the SBD. The bids shall be opened online at the office of the ***Joint Director, Construction Materials & Foundation Engineering Division, KERI Peechi***, at the above mentioned date and time by the ***Joint Director, Construction Materials & Foundation Engineering Division, KERI Peechi***, in the presence of the Bidders or their authorized representatives who are present at the time and venue. If the tender opening date happens to be on a holiday or non-working day due to any other valid reason, the tender opening process will be done on the next working day at the same time and place.

Tenders received online and the original received by post (except bid), without the necessary documents mentioned above will not be considered and shall be summarily rejected. Further details can be had from the Office of the ***Joint Director, Construction Materials & Foundation Engineering Division, KERI Peechi***, during working hours.

The firm period of the tenders shall be 60 days from the due date of submission of bid.

The bidder is advised to submit the bids well before the stipulated date & time to avoid any kind of network issues, traffic congestion, etc. In this regard, the department shall not be responsible for any kind of such issues faced by bidder. All other existing conditions related to the tenders of Kerala PWD / Irrigation Department will be applicable in this tender also.

Technical Specifications:

Digital Conversion Kit shall consist of the following components:

1. Digital Indicator - 1 No.

- Mode of Display : Micro controller multi line alpha numeric LCD display for all channel simultaneously (No need for channel selection)
- No of channels 3 –Nos

2. Load Cell - 1 No.
 - Capacity : 2 kN Universal Type
 - Max. overload : 110% of the rated capacity.
 - Sensing element : Strain Gauges in full bridge configuration.
3. Displacement Sensor - 2 Nos
 - Range : 0-20mm
 - Least count : 0.01 mm
 - Sensing element : LVDT

The Digital Conversion Kit shall be compatible with the existing Direct Shear Test Apparatus, make - Aimil Ltd., Model - AIM 104. Necessary mounting and interface accessories shall be provided by the supplier to ensure complete compatibility and functionality.

Other conditions

1. Manufacture should have ISO 9001 certification.
2. Supplier should have a service centre in Kerala
3. The supply should be made to Office of Deputy Director, Soil Mechanics and Foundation Division, KERI, Peechi.
4. The payment shall be done only after supply, installation and successful demonstration of the equipment in the laboratory.
5. The supplied equipment shall carry a minimum warranty of one (1) year from the date of successful installation and demonstration. Comprehensive technical support must be provided during the warranty period.
