4	Brief Description of Work	<p>Financial Sanction has been accorded for the work “Refurbishment of the Soil Mechanics Laboratory for NABL compliance ” for an amount of Rs. 8.00 Lakh as per Order No. CEIDRB/341/2025-DS-AD2 Dated 29-09-2025 of CE, IDRB.</p> <p>The current condition of the laboratory is not conducive to the standards expected for NABL accreditation, particularly with regard to the flooring and basic facilities. In most areas of the laboratory, the existing ceramic floor tiles have detached from the floor base and are broken or damaged, likely due to temperature variations and also may be due to vibrations by the operation of laboratory equipment. These deteriorated tiles are affecting the functionality and appearance of the laboratory.</p> <p>In view of this, it is proposed to completely remove the existing damaged ceramic floor tiles including skirting and new vitrified floor tiles of size 600 mm x 600 mm is proposed for laying using suitable adhesives and grouting materials. Matt/antiskid finish vitrified tiles of size 600 mm × 600 mm are proposed for the open verandah area between Soil Mechanics Laboratory and Seminar Hall, to prevent slippage.</p> <p>In addition to flooring works, the laboratory will also be upgraded with the construction of concrete slabs permanently resting on solid block masonry, which will serve as permanent storage platforms for keeping various laboratory equipment, glassware, and tools in an organised and safe manner. The estimate also includes the construction of operating platforms for installing machinery. These platforms will be built using solid block masonry and 20 cm thick 1:2:4 PCC layer proposed for the top surface. Provisions are given for shifting the exhaust vent of toilets to outer wall.</p> <p>Items for dismantling of exiting tile work, providing and laying vitrified floor tiles and Matt/Antiskid finish vitrified floor tiles, PCC 1:2:4, RCC 1:2:4, Steel reinforcement for R.C.C work with grade Fe-500D or more, Solid block masonry using precast solid blocks, 12mm cement plastering, Centering and shuttering, applying of Water thinnable cement primer and painting with acrylic emulsion paint are included in the estimate. Item for Engaging coolie for shifting furnitures and machineries in laboatory are also included.</p> <p>Estimate is prepared in DSR 2021 with cost index 144.45 (Thrissur District). The total estimated amount for the proposed refurbishment work is Rs.8,00,000/- inclusive of 18% GST.</p>

If the tender opening date happens to be on a holiday or non-working day due to any other valid reason, the tender opening process will be done on the next working day at same time and place.
